Axetris AG hereby certifies that the products described above conform to **Directive 2011/65/EC** of the European Parliament and of the Council of the European Union. Specifically, these products do not contain lead, mercury, cadmium, hexavalent chromium, polybrominated biphenyls (PBB) or polybrominated diphenyl ethers (PBDE). Any trace impurities of the RoHS substances in the parts are below the RoHS specified levels.



### REACH Compliance according regulation N° 1907/2006 (EC)

REACH - Regulation (EC) No 1907/2006 of the European Parliament and of the Council of 18 December 2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH), establishing a European Chemicals Agency, amending Directive 1999/45/EC and repealing Council Regulation (EEC) No 793/93 and Commission Regulation (EC) No 1488/94 as well as Council Directive 76/769/EEC and Commission Directives 91/155/EEC, 93/67/EEC, 93/105/EC and 2000/21/EC

REACH stands for Regulation, Evaluation, Authorisation and Restriction of Chemicals.

- Under the structure of the REACH Regulation, Axetris AG is a manufacturer and supplier of **articles**. We do not manufacture, or supply substances or mixtures and our articles do not involve intentional release of substances. For this reason, Axetris has not pre-registered or registered any products with the European Chemical Agency (ECHA).
- Regarding trade goods we asked our suppliers for a corresponding confirmation for compliance with the REACH regulation. All confirmations refer to the status "downstream user". This means that the registration of the products subjected to REACH regulation has been carried out by a former producer and/or supplier.
- Axetris is regularly monitoring the candidate list of substances of very high concern (SVHC) published by the ECHA. According to our current knowledge we can assume that no listed materials are used in our products.
